

2. The student will take a midterm and a final exam. Material will come from the assigned readings and class notes.
3. The student will write a research paper on a contemporary challenge posed to Christianity and the responsible Christian engagement in meaningful biblical and theological responses to that challenge. The paper needs to follow the Turabian format by using the WBU Religion Writing Lab Style Guide that I provide in form and documentation and use footnotes in the paper. The paper needs to include a title page, and a bibliography in addition to the 5 to 8 pages of text and requires a minimum of ten sources. Margins for the paper need to conform to the writing lab style guide, which states that you use 1 inch left margin and 1 inch margins elsewhere for the papers, 10 or 12 New Times Roman font, and double space the body of the paper. The body of the paper needs to be submitted to Safe Assignment in the Blackboard Classroom.
4. Each student will read the lecture notes on Blackboard and submit postings to the Discussion Board forums on the assigned weeks. The student posting needs to be a minimum of 175 words. Students need to read all other student postings and make a student response to at least one other student posting. The student response needs to be a minimum of 150 words. There will be one grade for each discussion board forum which includes both the student posting and student response.
